


Dear Donor(s),

About Us

New Life Charitable Trust (NLCT) is a social, health development and charitable non profit organization providing education to special children with disabilities, supporting poor people, orphans, destitute widows & unemployed women since 2017. Blessed Kids Special School run by NLCT is an innovative special school in Madurai, founded by Dr. B. Hemalatha BPT.,DHLS., MIAP. in 2017 to provide education and therapies to special children suffering from Cerebral Palsy, Mental Retardation, Autism, ADHD, Learning Disability, Down's Syndrome, Microcephaly, Hydrocephalus & Behavioural Problems.

Need For The Project

At present Blessed Kids Special School is operating in a rental building supporting 42 special children. We have received lot of requests for rescue and the need for shelter for destitute special children. However, we understand that we alone will not be able to cater to all the special children in the community but would like to support at least 70 children in 2 to 3 years. Maintenance and sustainability of the special school is a major issue and paying rent for a commercial building is an additional burden. Also, we are not able to ensure adequate space for all the activities and other physical needs of the special children.

One more pressuring issue is that we have shifted 3 buildings in the past year as the owners of the buildings are not willing to support these children. The noise made by the special children is a disturbing factor for the owners. This was a big burden in the past and also a concern in the future. It was hard to shift all the children and also finding a new building with sufficient space and necessary facilities and also recreating the atmosphere everytime is a challenging task.

Government approved special school:

Blessed Kids Special School is approved under **Commissionerate For The Welfare Of The Differently Abled** governed by District Differently Abled Office – Madurai. We have submitted all the statutory compliances and received NOC from Police department, Revenue department, Food and Safety department, Fire service, Sanitary department, building stability issuing officer etc.

The Certificate of Registration is awarded to **"Blessed Kids Special School"**, Located at Door No.8/3, Kalamman Kovil Street, Nehruji Main Road, New Vilangudi, Madurai District - 18, as an Institution for the persons with disabilities vide Reg.No.523/2022, under section 51 (2) of the RIGHTS OF PERSONS WITH DISABILITIES ACT, 2016 (Central Act 49 of 2016) to run a **Special School for Persons with Disabilities (ID), for Pre-Primary, Primary and Secondary classes.** This certificate of registration is valid from 18.07.2021 to 17.07.2024 and is subject to the following conditions:-

1. The Management should run the institution in accordance with Rights of Persons with Disabilities Act, 2016
2. Application for granting renewal of a certificate of registration should be submitted to this office two months in advance before the expiry of the period of validity.
3. The Institution should provide proper barrier free accessible environment & infrastructure facilities including sufficient accommodation. The institution has **13 Male & 17 Female Children only at present.** Based on the infrastructure the **capacity of the institution is fixed at 30 Children** with disabilities.
4. Rain Water Harvesting facilities should be made in the Institution immediately.
5. This certificate should be displayed by the institution in a conspicuous place.
6. The following words may be mentioned in the name board of the Institution **"Blessed Kids Special School Persons with Disabilities (ID)", Located at Door No.8/3, Kalamman Kovil Street, Nehruji Main Road, New Vilangudi, Madurai District - 18,** is registered under Section 51(2) of the Rights of Persons with Disabilities Act, 2016.

View Of Current Blessed Kids Special School RENTED Building



Goal:

Our primary goal is to establish a multi-facility special school which ensures the differently abled children a place of hope and respect to live. It will provide them a friendly atmosphere and ensures a quality of life which enable the children to retain their independence, identity and sense of value.



Progress So Far:

We are planning to purchase 6 cents of land and planning to construct a building for school. This includes reconstructing the living room, building class rooms, a kitchen and toilets with ramps and a provision for lift as the special children are unable to climb stairs. The proposed building of 2000 sq. ft. will be of ground and first floors which can accommodate 70 plus students as per government norms.

The proposed building will have separate reception and classrooms for 0-6 (pre-primary), 6-10 (primary), 10-14 (secondary) and 14-21 (vocational), medical and nursing care room, kitchen & dining hall, adequate toilet facility accessible to both active and non-active special children, therapy rooms, outdoor spaces, meeting hall and compound wall with CCTV setup.

Construction will be done by certified and experienced engineers qualitatively with proper plan and approvals from required departments and agencies.
